RESOLUTION NO. 33-2020

WHEREAS, the Caraga State University advertised the request for expression of interest for the Procurement of consultancy services for the Development of internationalization, global reputation, and excellence of Caraga State University thru and by associating with an internationally recognized brand with an Approved Budget for the Contract (ABC) amounting to **One Million Four Hundred Fifty Pesos (Php. 1,450,000.00)** posted in the www.carsu.edu.ph website, the Phil-GEPS and in conspicuous places within the premises of the Caraga State University;

WHEREAS, on the schedule of Eligibility Check and Shortlisting dated September 11, 2020 at exactly 2:00 PM, no Letter of Intent (LOI) and eligibility requirements have been submitted nor received from the prospective bidders for the consulting services project;


WHEREAS, Section 35.1 (c) of the Revised IRR of R.A. 9184 provides that the BAC shall declare the bidding a failure when all bidders failed to comply with the bid requirements;


WHEREAS, Section 35.3 of the same Act provides that the BAC shall conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the IRR;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVED**:

- a. To declare first failure of bidding on the project **RE: Procurement of consultancy services for the Development of internationalization, global reputation, and excellence of Caraga State University thru and by associating with an internationally recognized brand**;
- b. To recommend for re-bidding of the project **Re: Procurement of consultancy services for the Development of internationalization, global reputation, and excellence of Caraga State University thru and by associating with an internationally recognized brand as provided in Section 21.2 of the Revised IRR or RA 9184.**
