**A RESOLUTION TO HOLD THE ISSUANCE OF NOTICE OF AWARD (NOA) TO REDSEA AGRO INDUSTRIAL, INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE PROVISION OF MACHINERY AND EQUIPMENT OF DA-ACEF UPGRADING OF DAIRY CARABAO FACILITY**

**Resolution No. 55, s. of 2022**

**WHEREAS**, the Caraga State University (CSU) Bids and Awards Committee (BAC) recommended to award the contract for the project **PROVISION OF MACHINERY AND EQUIPMENT OF DA-ACEF UPGRADING OF DAIRY CARABAO FACILITY** per BAC Resolution No. 49, s.2022<sup>1</sup>;

**WHEREAS**, during the 69<sup>th</sup> CSU Board of Regents (BOR) Meeting, the recommendation of the BAC to award the contract to Red Agro Industrial Corporation was presented. The CSU BOR approved the recommendation of the CSU BAC to award the contract to the said bidder per BOR Resolution No. 69-05, s.2022;

**WHEREAS**, on November 10, 2022, the BAC was informed thru phone call by Dr. Tomas M. Austral, the End-User of the aforementioned project to put on hold the issuance of the Notice of Award (NOA) to Redsea Agro Industrial Corporation for the reason that their request for project extension and realignment were not approved by the funding agency due to the on-going processing of the board resolution authorizing DA-BAR's director to approve/disapprove requests of SUCs with regards to their ACEF R4D Projects;

**WHEREAS**, on November 21, 2022, Dr. Tomas M. Austral received an email from the funding agency informing that all project activities/operation should be put on hold until the request for extension and realignment is approved. Dr. Austral forwarded the same email to the CSU BAC Secretariat;

**NOW, THEREFORE, WE THE MEMBERS OF THE BIDS AND AWARDS COMMITTEE, AFTER CAREFUL DELIBERATION, RESOLVE, AS IT IS HEREBY RESOLVED:**

- A. To hold the issuance of the Notice of Award (NOA) to REDSEA AGRO INDUSTRIAL CORPORATION as the Lowest Calculated and Responsive Bidder (LCRB) for the Provision of Machinery and Equipment of DA-ACEF Upgrading of Dairy Carabao Facility until such time that the extension and realignment is approved;**




