**WHEREAS**, the Caraga State University advertised the Invitation to Bid of the Provision of I.T Equipment and Materials for the Operation of CSU Online Class and CEGS Lab. with an approved amount of Five Million Fifty Thousand Pesos (Php. 5,050,000.00) posted the same in the [www.carsu.edu.ph](http://www.carsu.edu.ph) website, the Phil-GEPS and conspicuous place within the premises of the Caraga State University;

**WHEREAS**, during the Opening of Bids on September 23, 2020 at exactly 2:00 PM, no bidder submitted its bid for the Provision of I.T Equipment and Materials for the Operation of CSU Online Class and CEGS Lab.;

**WHEREAS**, Section 35.1 (c) of the Revised IRR of R.A. 9184 provides that the BAC shall declare the bidding a failure when all bidders failed to comply with the bid requirements;

**WHEREAS**, Section 35.3 of the same Act provides that the BAC shall conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the IRR;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVED**:

- a. To declare first failure of bidding on the project RE: Provision of I.T Equipment and Materials for the Operation of CEU Online Class and CEGS Lab.;
- b. To recommend for re-bidding of the project Re: Provision of I.T Equipment and Materials for the Operation of CSU Online Class and CEGS Lab. as provided in Section 21.2 of the Revised IRR of RA 9184.
