

## CONTRACT AGREEMENT

### Provision of Highly Technical and Scientific Equipment for Engineering Laboratories to Strengthen Micro-Electronics, Renewable Energy, Robotics and Automation and Mining Engineering Technology

THIS AGREEMENT made the 04 JUN 2024 day of JUN 2024 between **CARAGA STATE UNIVERSITY** of the Philippines (hereinafter called "the Entity") of the one part and **MDC ELECTRICAL SUPPLIES AND SERVICES** located at Camansi St., Tiza Roxas City, Capiz (hereinafter called "the Supplier") of the other part;

    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the

4. The **CARAGA STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
