- The BAC Vice-Chairperson reiterated the Invitation To Bid (ITB) of the project with an Approved Budget for the Contract (ABC) of One Million Three Hundred Fourteen Thousand Thirty-four Pesos and Seventy Centavos Only (**Php.1,314.034.70**) funded from Regular Agency Fund (RAF) with a contract duration of three months and twenty-five calendar days.
- He then inquired from the concerned bidder for questions and clarification regarding the project.
